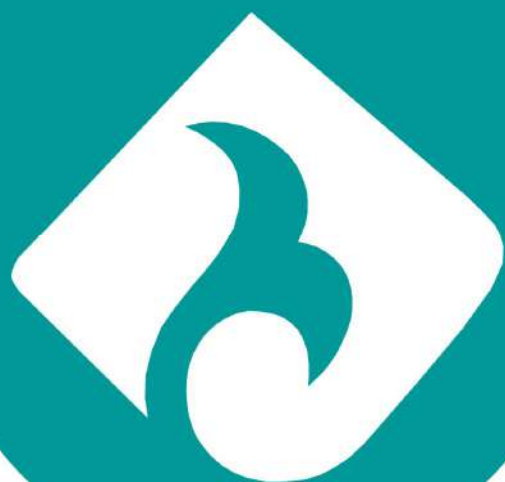

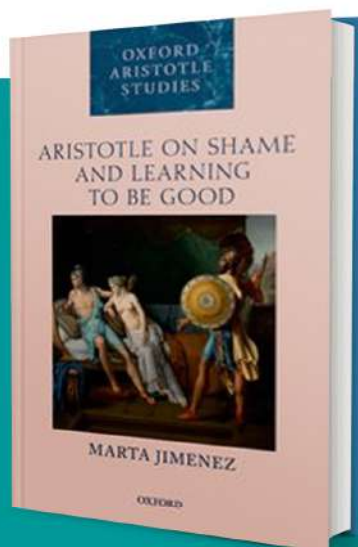

# Aristotle on Shame and Learning to Be Good



Marta Jimenez presents a novel interpretation of Aristotle's account of the role of shame in moral development. Despite shame's bad reputation as a potential obstacle to the development of moral autonomy, Jimenez argues that shame is for Aristotle the proto-virtue of those learning to be good, since it is the emotion that equips them with the seeds of virtue. Other emotions such as friendliness, righteous indignation, emulation, hope, and even spiritedness may play important roles on the road to virtue. However, shame is the only one that Aristotle repeatedly associates with moral progress. The reason is that shame can move young agents to perform good actions and avoid bad ones in ways that appropriately resemble not only the external behavior but also the orientation and receptivity to moral value characteristic of virtuous people.

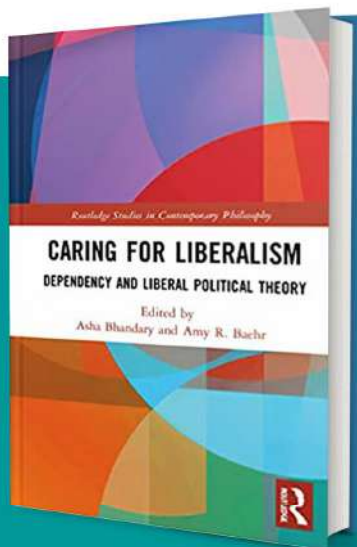

The chapters do not simply add care to existing liberal political frameworks; rather, they explore how integrating dependency might leave core components of the traditional liberal philosophical apparatus intact, while transforming other aspects of it. Additionally, the contributors address the design of social and political institutions through which care is given and received, with special attention paid to non-Western care practices.

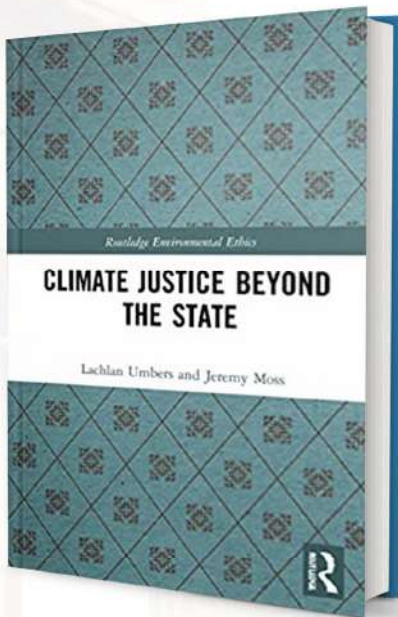

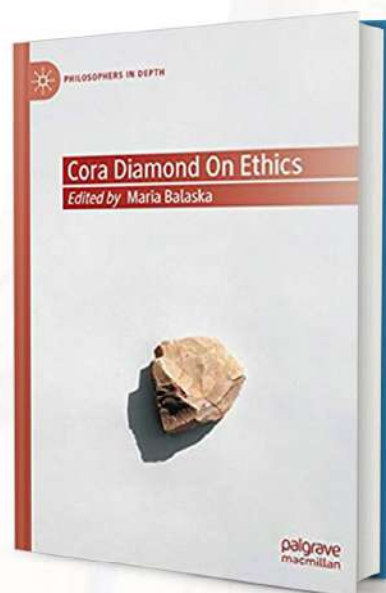

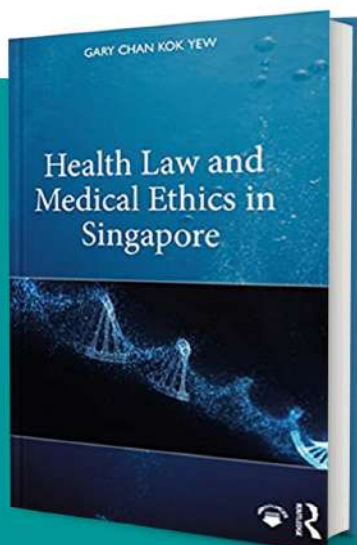
## Cora Diamond on Ethics

Some things are reasons for us to perform certain actions. That it will spare you great pain in the future, for example, is a reason for you to go to the dentist now, and that you are already late for work is a reason for you not to read the next article in the morning paper. 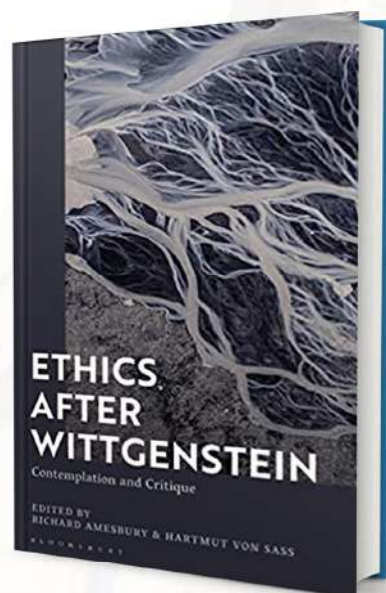
## Ethics after Wittgenstein

### Contemplation and Critique

What does it mean for ethics to say, as Wittgenstein did, that philosophy “leaves everything as it is”?

Though clearly absorbed with ethical questions throughout his life and work, Wittgenstein's remarks about the subject do not easily lend themselves to summation or theorizing. Although many moral philosophers cite the influence or inspiration of Wittgenstein, there is little agreement about precisely what it means to do ethics in the light of Wittgenstein.

*Ethics after Wittgenstein* brings together an international cohort of leading scholars in the field to address this problem. The chapters advance a conception of philosophical ethics characterized by an attention to detail, meaning and importance which itself makes ethical demands on its practitioners.



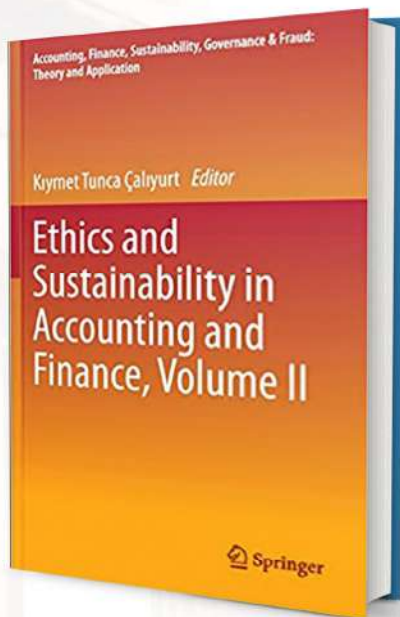

# Environmental Consciousness, Nature and the Philosophy of Education

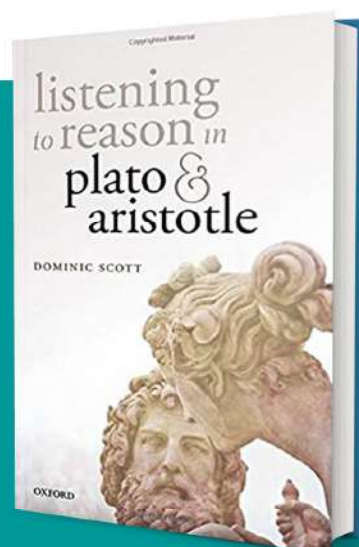

# Listening to Reason in Plato and Aristotle



Focusing on Plato's *Republic* and Aristotle's *Nicomachean Ethics*, this book compares their views on the persuasiveness of moral argument: how far did they think it could reach beyond a narrow circle of believers and influence people more generally? Answering this question requires a wide-ranging approach, which examines their views on such topics as rationality, moral psychology, rhetoric, education, and gender. The first part of the book shows that for Plato certain kinds of argument are beyond the reach of most people, specifically arguments that make appeal to transcendent Forms. But he still thought that there is another level of argument, restricted to human psychology and politics, which could have a much wider appeal, especially if supplemented by the appropriate rhetoric. The second half of the book turns to the *Nicomachean Ethics* to determine Aristotle's views about the reach of moral argument, as well as its purposes.

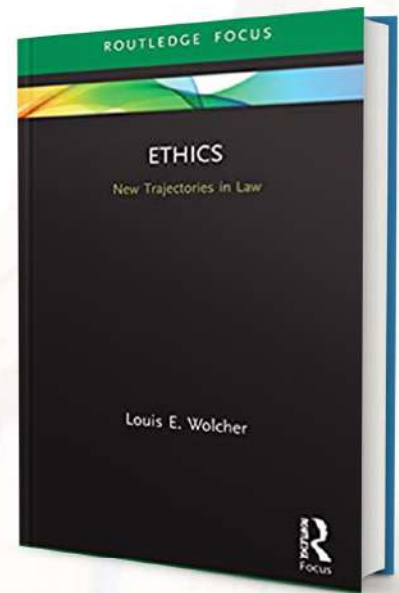

### New Trajectories in Law

This book examines ethics at the intersection of law and justice. If law and justice are concerned with collectively establishing the general terms on which the plurality called "we" share the earth as social beings, then ethics concerns the individual Self's particular moral relationship with the Other. Law, the acknowledged offspring of politics, represents the kind of might that most people accept as legitimate, at least most of the time. Justice, on the other hand, is supposed to vigilantly stand guard over law: to protect us against its biases and excesses, or, at the very least, to rise up and reproach the law whenever it permits or encourages injustice. But what if the belief that a particular legally-authorized state of affairs is "just" – a common enough feeling, especially amongst the privileged – or even "unjust" and in need of correction, were itself in need of a vigilant guardian?



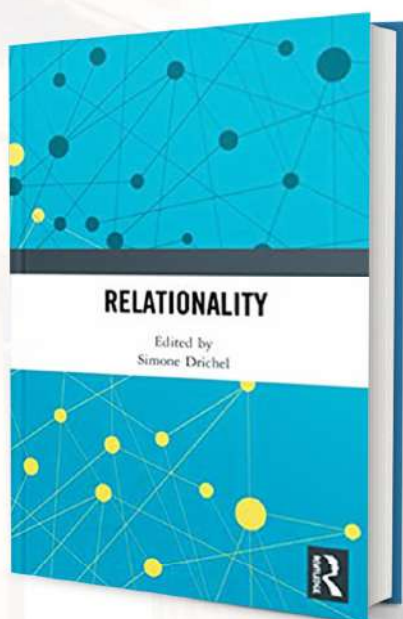

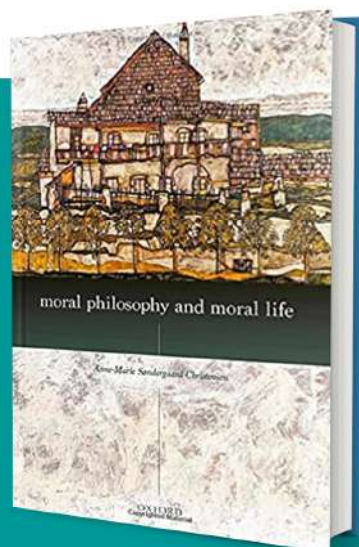

This book on Relationality addresses our growing "crisis of connection" by foregrounding the multi-faceted ways in which we are interconnected with each other and the world in which we live. When Niobe Way and her collaborators first proclaimed such a "crisis" in their 2018 book *The Crisis of Connection: Roots, Consequences, and Solutions*, they could not have foreseen the extremes of isolation and disconnection that Covid-19 would unleash just a couple of years later. Importantly, what such experiences of impaired and compromised relationality impress upon us—now more powerfully than ever—is just how fundamentally we are intertwined with each other and the world we inhabit.

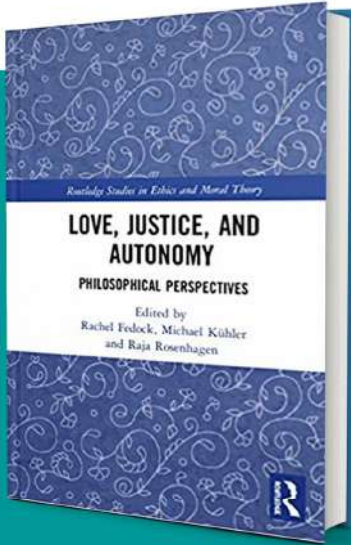

*Moral Philosophy and Moral Life* addresses the questions of the role of moral philosophy and its relationship to our ordinary moral lives. Christensen's argument is motivated by the belief that one of the most important obstacles for doing work in moral philosophy today is the lack of a coherent answer to the question of the role and status of moral philosophy and the theories it develops. The first part untangles various criticisms of the dominant view of moral theories that challenge the explanatory, foundational, authoritative, and action-guiding role of these theories. It also offers an alternative understanding of moral theories as descriptions of moral grammar.



# Love, Justice, and Autonomy

## Philosophical Perspectives



Philosophers have long been interested in love and its general role in morality. This volume focuses on and explores the complex relation between love and justice as it appears within loving relationships, between lovers and their wider social context, and the broader political realm. Special attention is paid to the ensuing challenge of understanding and respecting the lovers' personal autonomy in all three contexts. Accordingly, the essays in this volume are divided into three thematic sections. Section I aims at shedding further light on conceptual and practical issues concerning the compatibility or incompatibility of love and justice within relationships of love. For example, are loving relations inherently unjust? Might love require justice? Or do love and justice belong to distinct moral domains? The essays in Section II consider the relation between the lovers on the one hand and their broader societal environment on the other. Specifically, how exactly are love and impartiality related?

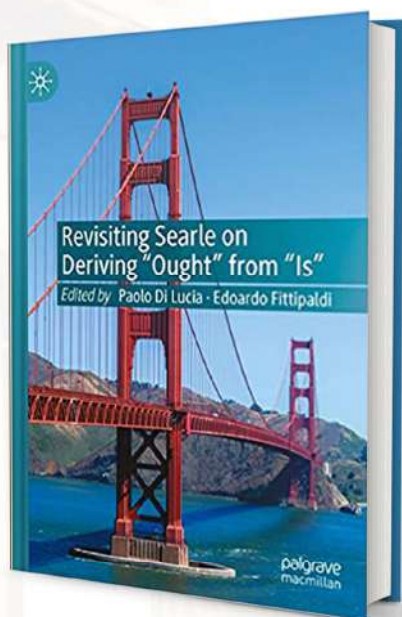

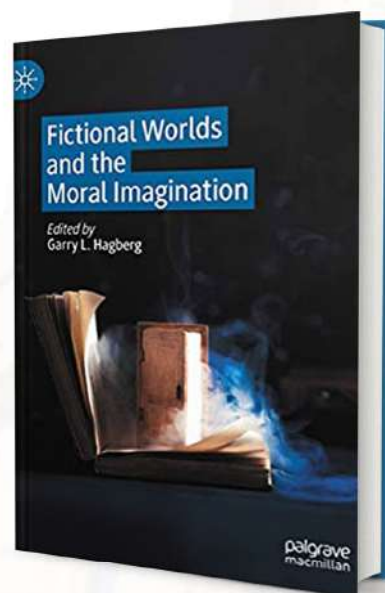
This book reconsiders the supposed impossibility of deriving "Ought" from "Is". John R. This volume opens with a brand new chapter from Searle who, in light of his subsequent philosophical developments, expounds the reasons for the validity of that derivation and its crucial significance for social ontology and moral philosophy.

In philosophical contexts of ethical inquiry we can too easily forget that literary experience can play an important role in the cultivation of our ethical sensibilities. However, as this stimulating volume shows, the dichotomy between fact and fiction cannot be so easily categorised. Moral perception, moral sensitivity, and ethical understanding more broadly, may all be developed in a unique way through our imaginative life in fiction.

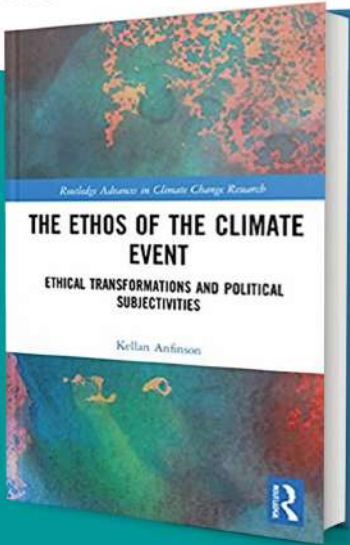

# The Ethos of the Climate Event

Ethical Transformations and Political Subjectivities



This book develops a politico-ethical response to climate change that accounts for the novelty and uncertainty that it entails.

This volume explores the ethical dimensions of climate change and posits that one must view it as a social construction intimately tied to political issues in order to understand and overcome this environmental challenge. To show how this ethos builds upon the need for new forms of responsiveness, Anfinson analyzes it in terms of four features: commitment, worldly sensitivity, political disposition, and practice. Each of these features is developed by putting four thinkers – Kierkegaard, Nietzsche, Schmitt, and Foucault respectively – in conversation with the literature on climate change. In doing so, this book shows how social habits and norms can be transformed through subjective thought and behavior in the context of a global environmental crisis.

This book investigates how we should form ourselves in a world saturated with technologies that are profoundly intruding in the very fabric of our selfhood.

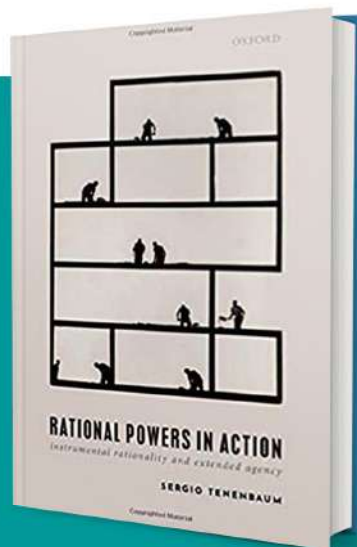

# Rational Powers in Action

Instrumental Rationality and Extended Agency



Human actions unfold over time, in pursuit of ends that are not fully specified in advance. *Rational Powers in Action* locates these features of the human condition at the heart of a new theory of instrumental rationality. Where many theories of rational agency focus on instantaneous choices between sharply defined outcomes, treating the temporally extended and partially open-ended character of action as an afterthought, this book argues that the deep structure of instrumental rationality can only be understood if we see how it governs the pursuit of long-term, indeterminate ends. These are ends that cannot be realized through a single momentary action, and whose content leaves partly open what counts as realizing the end. Sergio Tenenbaum argues that we need to focus on temporal duration and the indeterminacy of ends in intentional action, even to explain the rational governance of relatively simple actions.

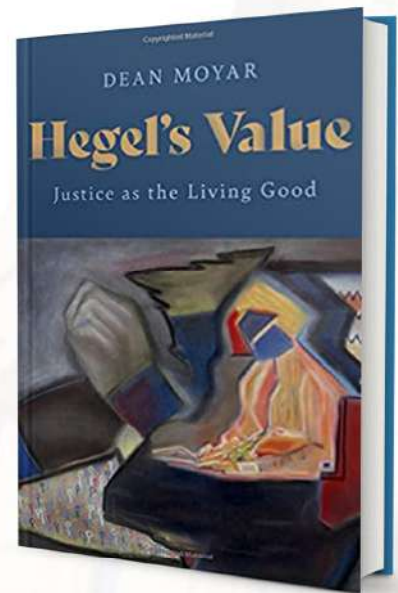

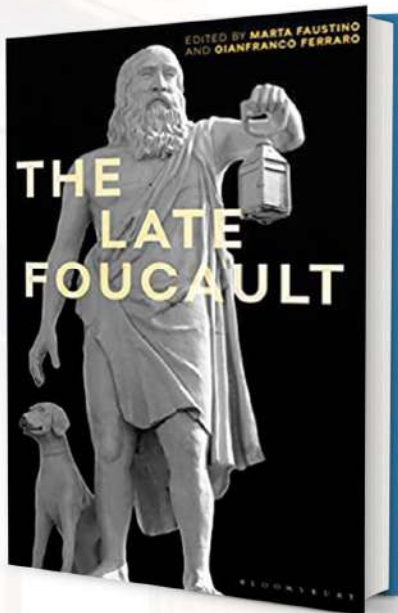
## Hegel's Value

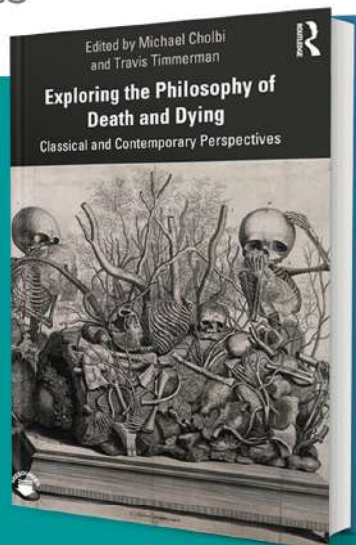
## The Late Foucault

The recent publication of his last lecture courses at the Collège de France (1981-1984), together with the short texts, essays, and interviews from the same period, have sparked new interest in his work, allowing for a new understanding of his philosophical trajectory and challenging several interpretations produced over the last few decades.
